Please be aware that this form may not be used to request changes to: any clauses in the S51A agreement, the design of the scheme, the scope of the construction works or the quoted cost of the works.

If you need to request a change to the design of the main scheme or the scope of the works, you'll need to complete our **re-design / re-approval request form**, which you can find at yorkshirewater.com/developers/water/self-lay/.
