This request form should only be used if you have received a 'Full Provisional Certificate' or a 'Provisional Certificate with Defects' for your site put forward for adoption under Section 104 of the Water Industry Act 1991.

A Final Inspection confirms that the site has reached the end of its maintenance period, the proposed adoptable system has been operating as expected during this time (with no operational issues) and there are no outstanding remedial works to complete.

To arrange a final inspection with one of the team, please complete this request form and email it to technical.sewerage@yorkshirewater.co.uk, along with the requested supporting information.

What happens next?

On receipt of your request form and supporting information, an Adoptions Agent will review all the information to ensure it is compliant with the Code for Adoption.

If all the necessary information has been provided, the Adoptions Agent will instruct our scheduler to contact you within 14 calendar days to confirm a convenient date and time of your final inspection with a Developer Services Inspector. They will also confirm who should be present on site during the inspection.

If the information received is not sufficient, the Adoptions Agent will contact you to discuss the outstanding matters.

This form must only be completed, signed and submitted by the developer for the site.

Please ensure all outstanding fees owing to Yorkshire Water have been paid prior to submitting this form.
