A meter of a pattern to be approved by the River Authority shall be installed to measure the quantity of water abstracted and the quantity so measured shall be to en the quantity abstracted.

The meter shall be maintained in good working order and shall be read monthly. Records shall be kept of the readings and shall be produced on request to Officers of the River Authority at all reasonable times.

FOR SPECIAL CONDITIONS SEE OVER

The variation of this licence is approved subject to the following conditions:-

- 1. Satisfactory detail plans, sections and elevations of the design and materials of construction of the intake and of the arrangements for securing the passage of the prescribed flow referred to in condition 2 hereof shall be submitted to and approved by the River Authority before any work is commenced.
- 2. A flow of not less than 0.273 Ml/d (60,000 g.p.d.) shall remain in Mill Beck immediately downstream of the abstraction point during all periods when abstraction takes place under this variation.
