This application form should be used if you would like to request for Yorkshire Water to provide a public sewer for the drainage for domestic purposes under Section 98 of the Water Industry Act 1991.

If your development has no way of draining to a public sewer due to the land between the site and the sewer being owned by a third party, and they will not give you access to the land, you can requisition (formally request) a public sewer. This means Yorkshire Water would undertake the work to install public sewers for the site.

We are happy to have a pre-application discussion with you prior to you submitting the form to ensure we understand your requirements fully. Please contact our Sewer Diversion and Requisition team in Developer Services.

On submission of this application form, please ensure that you attach all technical details and detailed plans required to support your application.

Please ensure you provide a covering letter with your application detailing any site specific information.

The information you provide will be used solely in accordance with Yorkshire Water's [Privacy Policy](#). Please be aware, we may contact you to seek feedback on your experience with this service.

The fees for a sewer requisition are as follows:

Application Fee – £1,900.00

Initial Meeting / Site Visit – £180.00 per hour

Feasibility Study – minimum £14,288.00

Please note: if the proposed solution is complex the costs for this can be higher.

Legal Fees – Bespoke

Whole Costs of Works – these are bespoke site specific fees.

The estimated final cost will be provided as part of the Feasibility Study.

All fees will be invoiced direct to the developer unless otherwise stated.

Please await invoice before making payment.

What happens next?

You will receive an acknowledgement letter within five calendar days confirming receipt of your application.

We will then undertake an initial assessment of the application and provide you with an estimate for the cost and expected timescale for the Feasibility Study within 14 calendar days.
