This application form should be used if you would like to request to divert or alter a major public sewer and/or Yorkshire Water critical asset under Section 185 of the Water Industry Act 1991, where works would be undertaken by Yorkshire Water.

Where a public sewer crosses the site, a developer may request for us to undertake a reasonable diversion or alterations of it. We will undertake the works and all costs involved are payable by the developer. This is a chargeable service, details of which can be found in our Charging Arrangements for 2023/24.

We are happy to have a pre-application discussion with you prior to you submitting the form to ensure we understand your requirements fully. Please contact our Sewer Diversion and Requisition team in Developer Services.

On submission of this application form, please ensure that you attach all technical details and detailed plans required to support your application.

Please ensure you provide a covering letter with your application detailing any site specific information.

No alteration to the public sewer network can be made until the signed agreement is in place.

The fees for major sewer diversions/alterations are as follows

Application Fee – £500.00

Initial Meeting / Site Visit – £84.00 per hour

Feasibility Study – minimum £9,146.00

Please note: if the proposed alterations are complex the costs for this can be higher.

Legal Fees – minimum £800.00

Whole Costs of Works – these are bespoke site specific fees.

The estimated final cost will be provided as part of the Feasibility Study.

All fees will be invoiced direct to the developer unless otherwise stated.

Please await invoice before making payment.

What happens next?

You will receive an acknowledgement letter within seven calendar days confirming receipt of your application.

We will then undertake an initial assessment of the application and provide you with an estimate for the cost and expected timescale for the Feasibility Study within 14 calendar days.
