# 8. MEANS OF MEASUREMENT OR ASSESSMENT OF WATER ABSTRACTED

- 8.1 The quantity of water abstracted in virtue of this licence shall be measured by a meter, such meter to be read monthly, and the quantity recorded by the meter shall be taken to be the quantity of water abstracted.
- 8.2 The Licence Holder shall fix and maintain a measuring notch or weir at the exit from the stilling basin into Silsden Beck, together with a gauge board to show the depth of water flowing over the notch or weir and marked at levels corresponding to flows of 3,318.64 cubic metres per day and 2,409.42 cubic metres per day.

#### 9. FURTHER PROVISIONS

9.1 No water shall be abstracted from the stilling – basin when the flow over the notch or weir is less than 2,409.42 cubic metres per day.
