This request form should only be used if you require a variation to the signed S104 Agreement for your site under Section 104 of the Water Industry Act 1991.

A S104 Agreement is entered into by the relevant parties and once signed is legally binding until the system has been formally vested by Yorkshire Water. The site layout drawing incorporated within the S104 Agreement shows the sewers and associated assets proposed for adoption by Yorkshire Water.

Should a developer wish to amend the proposed adoptable sewer and associated assets within the S104 Agreement, a variation can be requested. Yorkshire Water shall determine whether this can be done by correspondence, by a Deed of Variation or whether the S104 Agreement needs to be terminated and a new Agreement put in place.

For any variations that directly impact on the hydraulics of the proposed network, a formal resubmission must be made. For any variations that do not impact on the hydraulics of the network, these can be approved by the Developer Services Inspector and confirmed on the as built drawings.

To request a variation, please complete this request form and email it to technical.sewerage@yorkshirewater.co.uk, along with the requested supporting information.

What happens next?

On receipt of your request form and supporting information, an Adoptions Technician will review all the information and acknowledge your request within 7 calendar days. The Adoptions Technician will respond to you, confirming the type of variation required.

If all the necessary information has been provided, the Adoptions Technician will complete their assessment of the variation within 14 calendar days.

If the information received is not sufficient to complete their assessment, the Adoptions Technician will contact you to discuss the outstanding matters within 14 calendar days.

Once the details of the variation have been confirmed by all parties, the variation will be drawn up and acceptance provided within 7 calendar days.

This form must only be completed, signed and submitted by the developer for the site.
