This is an application for sewer closure or abandonment. If you need to abandon or remove a sewer to make way for a new development, you must send us an application under section 116 of the Water Industry Act 1991 so that we can make sure the sewer is no longer needed.

Once we've approved your application, you are responsible for arranging the sewer closure and abandonment works with a suitably qualified drainage contractor. Our inspector will monitor the work to make sure it's carried out to the required standard. Please call 0345 1 20 84 82 (Option 1) to arrange for the inspector to visit your site before you start to excavate and remove the public sewer.

Our preferred method for abandoning a sewer is for it to be grubbed up (excavated) together with any redundant chambers. If this isn't practical, we recommend sealing and filling the closed public sewer with grout.

How long will it take to get a response?

We aim to send you confirmation that we've received your application within **5 calendar days**. Once we receive your completed application and payment, we'll do a technical assessment and aim to issue a response within **14 calendar days**.
