This request form should only be used if you have received Conditional and / or Technical Acceptance for your design proposals for your site put forward for adoption under Section 104 of the Water Industry Act 1991.

Conditional and / or Technical Acceptance confirms that Yorkshire Water are satisfied the design of the prospective public sewers and associated assets will be constructed in accordance with the Design and Construction Guidance, Local Practices and Technical Standards contained within the Code for Adoption.

Please note, where a site has a diversion incorporated within the S104 application, no works on the diversion should take place until the Legal Agreement has been drawn up and signed by all parties.

Prior to any construction works in relation to the proposed adoptable network starting on site, a pre start inspection meeting must be held. If works have already started prior to the meeting being held, then that is done so at entirely the developers own risk and cost.

Please note that there is a risk that because of the partial nature of a site approval (Conditional Acceptance), changes may be required in order to reach Technical Acceptance, resulting in laid sewers needing to be altered to meet the requirements of the Technically Accepted system. Any alterations required will be at the developers own risk and cost.

To arrange a pre start inspection meeting with one of the team, please complete this request form and email it to technical.sewerage@yorkshirewater.co.uk, along with the requested supporting information.

What happens next?

On receipt of your request form and supporting information, an Adoptions Technician will review all the information. If all the necessary information has been provided, the Adoptions Technician will instruct our scheduler to contact you within 7 calendar days to confirm a convenient date and time of your meeting with a Developer Services Inspector. They will also confirm who should be present at the pre-start meeting.

If the information received is not sufficient, the Adoptions Technician will contact you to discuss the outstanding matters.
