

Despite all our checks, sometimes small errors can slip through, or we may need to make changes after getting clarification from our regulator, Ofwat. Instead of just updating the information in our APR, we think it's better to be open and let you know about any changes we make.

Why have these data items changed?

After our original submission, we asked Ofwat for more clarity to help us better understand this data table. This confirmed that for the 2023/2024 reporting, Ofwat's expectation was for companies to provide the total number of penalty payments and the corresponding value in 2N.62, and not in 2N.51 and 2N.52.

After reviewing this, we believe that our original submission may not have fully aligned with Ofwat's guidance. We had included the number of events and payment value of GSS penalty payments in Lines 50 and 51, and also included penalty payments in the data to obtain the number for Line 53. All three numbers have been updated.

Whilst reviewing these lines to establish that they equal the number of events in column D, (Lines 2N.53 to 2N.60), we established that some values were incorrect as they were based on unique properties rather than events. The numbers in column D on Lines 2N.53, 2N.56, 2N.57, 2N.58, 2N.59 and 2N.60 have been revised to include all events.

Why have these data items changed?

In our original submission, we thought the reporting requirements for the affected lines were separate from each other, not a part of one another. We've now realised this was wrong and the updated tables have been corrected.

Why have these data items changed?

There was an error in our original submission, where 3F.7 didn't align with Data Item 4R.27 as the Ofwat guidance states. The correction is to align the two figures, correcting the 3F.7 value, keeping the 4R.27 unchanged.

Why have these data items changed?

A manual typo error was spotted following our original submission, where -100.0 was entered rather than the correct -200.0 value. This has now been corrected.

A late change to 'Funds From Operations' (FFO) didn't get picked up in the calculations for Data Items 4H.15 and 4H.16. Updated calculations have now been made to reflect the accurate value.

The original values we published were mistakenly taken from an outdated version of our internal Enhancement Allowances. We've now corrected this using the most recent version.

Why have these data items changed?

The overall stated capital expenditure of $\pounds 6.062m$ was correct, however, this should have been split between the AMR and AMI columns (F & G), as we started installing AMI meters as part of our new optant meter installation in September 2023. A total of $\pounds 2.102m$ has been moved from AMR to AMI to correct the reporting.

Following our original submission, we noticed that we'd incorrectly cited the DWF permit rather than the required "Average annual flow to treatment". We've now corrected this error.
