Enforcement Position**

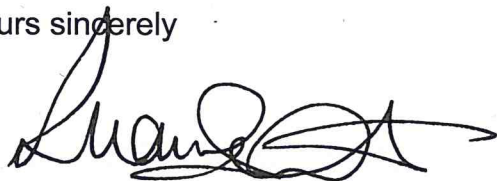
The Environment Agency confirms that it will not take enforcement action for failure to comply with the compensation requirements in the Reservoir Acts appended to this letter, provided that the alternative compensation requirements listed are met. The Environment Agency has taken this position because the alternative compensation requirements are better for the environment and for water supply.

This Enforcement Position is specific to Yorkshire Water only. It will remain in force until further notice.

All other existing permit conditions continue to apply as they are and the Environment Agency's normal enforcement procedures will apply in relation to any breaches of those conditions, or if we consider that the activities are likely to cause pollution of the environment or harm to human health or if such pollution or harm is caused. In that event, enforcement action may be taken against any party whom we consider is liable for any breach or pollution or harm.
